

RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AGREEMENT

By signing this Release and Waiver of Liability, Assumption of Risk, and Indemnity Agreement (Release), I represent that I have read this agreement and that I fully understand the agreement. I further represent that I understand the nature of the activities that take place at Global Franchise Development Corporation d/ba Hell Survivors (Hell Survivors) and that these activities involve the risk of serious bodily injury including but not limited to permanent disability, paralysis and even death. I represent that I am in good health and proper physical condition to participate in these activities. I understand the nature and risk of participating in paintball or air soft at Hell Survivors. I understand that this release is intended to include all activities whether on or off the playing field or whether before, during or after playing on the field in connection with any event and/or activity at Hell Survivors. I further understand that I may sign releases in the future. I understand that this release and any subsequent release does not expire, that each release is intended to be effective each and every time I enter the premises of Hell Survivors.

If I believe event conditions are unsafe, I will immediately discontinue participation in the activity. I fully understand that these activities involve risks of serious bodily injury, including permanent disability, paralysis and death, which may be caused by my own actions, or inactions, those of other participants, the conditions of the premises, or the acts or omissions of the "Releasees" named below: and that there may be other risks either not known to me or not readily foreseeable at this time: and I fully accept and assume all such risks and all responsibility for losses, costs, and damages I incur as a result of my participation or presence at Hell Survivors

I Hereby release, discharge, and covenant not to sue Hell Survivors, its respective administrators, directors, agents, Officers, volunteers, and employees, other participants, any sponsors, advertisers, and if applicable, owners and lessors of the premises on which the activity takes place, (each considered one of the "RELEASEES" herein) from any and all liability, claims, demands, losses, or damages on my account caused or alleged to be caused in whole or in part by the acts or omissions of the "releasees": and I further agree that if, despite this release, waiver of liability, and assumption of risk, or anyone on my behalf, makes a claim against any of the releasees, I will indemnify, save, and hold harmless each of the releasees from any loss, liability, damage, or cost including attorney fees which any may be incurred as the result of such claim.
