## RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AGREEMENT

By signing this Release and Waiver of Liability, Assumption of Risk, and Indemnity Agreement (Release), I represent that I have read this agreement and that I fully understand the agreement.
